"Practicing FFT with Dignity and Depth Across the Globe: Integrity, Innovation, and Diversity"

## **Program Overview**

The theme for the 3<sup>rd</sup> International Conference on FFT is highlighting what it takes to practice FFT with dignity and depth. As FFT nears its 50-year anniversary, our understanding of how FFT works has become increasingly sophisticated and clear. The international success of FFT is due to the model's ability to accommodate or match to families in diverse settings. We will look at how this matching occurs and explore similarities and differences in the global implementation of FFT.

Presentations will cover diverse topics that are relevant to clinical implementation, including how to practice FFT with marginalized, disenfranchised families, the role of emotional expression in the change process, and variations in relational functions. Invited presentations will also focus on innovations in implementation of FFT with new populations and strategies.

FFT has also helped international sites to sustain, achieve positive outcomes, and see great cost saving through their implementation efforts. Conference presentations will cover topics relevant to supervisors, administrators, and community stakeholders. In addition, presentations will include new research findings from multiple projects that have been completed since the last conference.

Presentations will include expert panels with members from Australia, Denmark, Egypt, England, The Netherlands, New Zealand, Norway, Scotland, Singapore, and Sweden.

9:20am What it Takes to Change: Going Deep with Families and Communities

The opening plenary of the conference presents a broad overview of the foundations of the FFT model and how the model leverages change by systematically and strategically addressing risk and protective factors. This presentation will provide an overview of the challenges and successes of implementation of FFT in diverse international contexts and a discussion of what the future holds for the growth of FFT.

This panel will highlight the challenges of working with youth and families in contexts of severe historical and ongoing marginalization and abuse. The impact of colonization, racism, and inter-generational trauma will be discussed. This panel will emphasize how FFT has effectively built relationships at multiple levels (youth, family, agency, community) to build trust and launch a change process. Panelists from Australia, Zealandia, and Europe will share their unique stories about the healing process with youth and families.

1:00pm Practicing with Dignity and Depth – Panel 2

This panel will focus on similarities and differences across cultures in how to access and work with emotions in FFT. The flexibility of FFT in matching to families is a unique and powerful aspect of FFT. As a principle, the concept of matching is a constant reminder about the variability that is expected in clinical practice. This panel provides an overview and specific examples of some of the unique and common ways in which emotions are manifested and addressed across cultures. Panelists will include representatives from Europe, Singapore, and North America.

However, very little has been discussed about cultural similarities and differences in patterns of relational functions and how these patterns might be related to clinical processes and outcomes.
